CUSTOMER WARRANTY STATEMENT

ACDelco Advantage Bearing Products Limited Warranty

ACDelco Advantage Bearing products are warranted by ACDelco, a division of General Motors of Canada Limited ("ACDelco" or "General Motors"), to the original retail purchaser against defects in materials or workmanship for the applicable warranty period as described in this warranty statement. ACDelco's only obligation under this warranty is to provide a replacement Advantage Bearing product at no charge. Any replacements under this warranty will receive the balance of the original warranty period or three (3) months, whichever is greater.

This warranty only applies to ACDelco Advantage Bearing products purchased and installed on passenger cars or light trucks (less than 8,600 lbs. gross vehicle weight) on or after December 1, 2013 and primarily for use in Canada. In addition, this warranty only applies to the Advantage Bearing product line launched by General Motors in December 2013. The warranty period starts at the time of sale to the original retail customer.

ORIGINAL RETAIL PURCHASER'S OBLIGATIONS ARE:

Return the defective product to the place of purchase in Canada, along with the original sales receipt, invoice, and/or repair order as proof of purchase. The original retail purchaser will receive a new replacement ACDelco Advantage Bearing product in exchange at no charge.

THIS WARRANTY DOES NOT COVER:

- Failure caused by negligence, alteration, accident, abuse, improper installation or adjustment, failure to maintain, or a use for which the part is not designed or approved by ACDelco.
- Products repaired or replaced under any new or used vehicle warranty.
- Products used in police vehicles, taxis (or other for-hire vehicles), and vehicles used primarily for off-road, off-highway or agricultural purposes, as well as vehicles used for racing or other competitive applications, or in applications not referenced in product or vehicle catalogues.

- Labour to repair, inspect, remove, or reinstall the product on the vehicle.
- Incidental or consequential damages or loss connected with the failure of the product, for example loss of time, towing, product return costs, inconvenience, loss of use, the cost of a rental car, travel, lodging, the loss of personal or commercial property, the loss of revenue, etc..
- Products used in vehicles registered and normally operated outside of Canada.
- Any products used in a vehicle where the vehicle odometer has been disconnected or the mileage/kilometer reading has been altered.
- Any product not purchased by your vendor/dealer from ACDelco.

OTHER TERMS:

To the full extent permitted by applicable Canadian law:

- The foregoing warranty is the only and the entire warranty provided by ACDelco and is lieu of and excludes all other representations, warranties or conditions, express or implied (including any implied warranty of merchantability or fitness for a particular purpose).
- The provision of replacement parts as discussed above, is the exclusive remedy under this written warranty or under any otherwise applicable implied warranty or condition.

No modifications to warranty

- ACDelco does not authorize any person, including a General Motors of Canada dealer or ACDelco distributor, to create for it any other obligations or liability in connection with the products and no person is permitted to extend or enlarge this warranty on behalf of ACDelco by any written, verbal or other representation and if made, such representation or warranty will not be enforceable against ACDelco.

Disclaimer of liability

- Except as expressly provided in this limited warranty, ACDelco will not be liable in contract, tort or otherwise for any direct, indirect, economic, commercial, incidental or consequential or special loss or damage or expense or claim, however caused, arising in connection with the sale, use, loss of use, performance or non-performance of the product.

Notice regarding limitations:

- The terms and conditions contained in this limited warranty are not intended to limit or otherwise modify or exclude any warranty or condition that by law cannot be limited, disclaimed or excluded. If and to the extent that any applicable law prohibits any term or condition contained in this warranty, such term or condition will be considered severable and deemed deleted from this warranty.
